Summer Village of Mewatha Beach Bylaw 2/99

A Bylaw of the Summer Village of Mewatha Beach, in the Province of Alberta for the purpose of establishing the administrative structure of the Summer Village of Mewatha Beach in relation to the Freedom of Information and Protection of Privacy Act, and to set fees thereunder.

WHEREAS, pursuant to Section 89 of the Freedom of Information and Protection of Privacy Act, S.A. 1994, c.F-18.5, the Summer Village of Mewatha Beach must designate a person or group of persons as the head of the Summer Village for the purposes of the Act; and

WHEREAS, pursuant to Sections 87 and 89 of the Freedom of Information and Protection of Privacy Act, the Summer Village of wathabeach may set any fees payable to the Summer Village for services under the Act and Regulations.

NOW THEREFORE, the Council of the Summer Village of Mewatha Beach, in the Province of Alberta duly assembled hereby enacts as follows:

PART I: BYLAW TITLE

1. That this bylaw shall be known as the "Freedom of Information and Protection of Privacy Bylaw".

PART II: PURPOSE OF BYLAW

1. The purpose of this bylaw is to establish the administrative structure of the Summer Village in relation to the Freedom of Information and Protection of Privacy Act, and to set fees thereunder.

PART III: DEFINITIONS

Act the Freedom of Information and Protection of Privacy Act, S.A. 1994, c.F-18.5;

Applicant a person who makes a request for access to a record under Section 7(1) of the Act;

Chief Administrative

Officer the Summer Village Administrator, as appointed pursuant to the Municipal Government Act.

Province the Province of Alberta

Summer

Village the Summer Village of Mewatha Beach and includes any board, committee, commission, panel, agency or corporation that is created or owned by the Summer Village of Mewatha Beach and all the members or officers of which are appointed or chosen by the Summer Village.

PART IV: DESIGNATED HEAD

1. For the purpose of the Act, the Summer Village Administrator is designated as the Head of the Summer Village.

PART V: FEES

1. Where an Applicant is required to pay a fee for services, the fee payable is in accordance with the Freedom of Information and Protection of Privacy Regulation, AR 200/95, as amended from time to time or any successor Regulation that sets fees for requests for information from the Province.

This Bylaw shall come into force and effect upon the date of the passing of the Third and Final Reading and signing thereof.
